## Consultation on St Chad's CE Nursery & Infant School Admission Arrangements for September 2023

The admissions policy has been adapted to ensure we are fully compliant with the new School Admissions Code (2021) and there have been **no** changes to the school's oversubscription criteria.

Please note that all responses need to include your school's name and should outline your personal details, including your name, address and relationship to the school.

At the end of the consultation period, the governing body will meet to consider responses. The outcome of the consultation will be published on the St Chad's CE Nursery & Infant School website as soon as possible following a decision being reached by the Local Governing Body.
